

## PAUL BUNYAN DAYS LABOR DAY WEEKEND

Paul Bunyan Day's is a 4 day celebration of our logging history in St. Maries Idaho. It is held each year during Labor Day Weekend. We have several food and craft vendors, a Carnival (Davis Shows North West), logging and water events, Outhouse and Bed races, Tug of War contest, Lawn Mower Racing , Kids events, Quilt Show, Motor Cycle Enduro racing, and the largest fireworks display in the Northwest, Parade and entertainment through out the weekend. The attendance for The 4 day celebration is estimated at 25,000 people, we don't charge for parking or admission to the park or any of our events. We do cash pay outs to all winners of the events which is getting more involvement every year. This is totally a family fun weekend.

We are in the process of setting up vendor space for this year. We have between 25-35 vendors every year, the space is very limited and most of our previous vendors will be returning. Because of the limited space and attendance we only allow 2 vendors selling same item or product. We opened up a new area this year where the Topless Bar (beer garden) use to be and will put vendors in that area surrounded by trees. Previous year vendors are chosen over new vendor if application is received by APRIL 15<sup>TH</sup> 2011, after that date all new vendors will be consider and notified. We are very limited to Cargo or Trailer vendors at this time we only have a couple of spaces to put them. We do have space for canopy type vending. **Paul Bunyan Requirements: Each Vendor is responsible for providing their own tables, chairs shelves, and any other props necessary for booth set up. 110volt power is provided. Each vendor must provide extension cords, recommend 50’ 12 gauge. NO ALCOHOL ON VENDORS PREMISES AT ANY TIME.**

**Those Commercial Vendors who bring their pets with them are not allowed out during hours of operation. Vendors vehicles are not allowed in and out of park during hours of operation NO EXCEPTIONS. Vendors that have to use Generator Power can not use them past 10pm no exceptions.**

**Vendors may not lease or resell their vendor space without permission from the Paul Bunyan Committee**

**Commercial Vendors are required to provide liability insurance**

**Selection Process: All vendors need to adhere to all requirements. Returning vendors from previous year with the same application and meeting the dead line**

date will have preference over any new vendor. We only allow 2 vendors selling the same item or menu.

**Hours of Operation:** Friday 12 noon- 10pm , Saturday and Sunday 10am-10pm  
Monday 11am-4pm

**Hours for daily setup:** Friday 8am-12noon-Saturday, Sunday, and Monday  
anytime before opening

**Tear Down:** Can not begin before 9pm each day of operation, Exception is Monday  
not before 6pm unless other arrangements are made by the committee

**Security:** Security at this time is not provided by the Paul Bunyan Committee, all  
vendors are responsible for their own security.

**HOLD HARMLESS AGREEMENT:** In signing this agreement, the applicant  
agrees to comply with all the Paul Bunyan Days Inc, State and Local Regulations
